

## OFFICIAL TOOLBOX SWEEPSTAKES RULES

NO PURCHASE NECESSARY TO ENTER OR WIN.

### SWEEPSTAKES DESCRIPTION:

BendPak will run a secondary sweepstakes ("Toolbox Sweepstakes") to help promote the "Post For Posts" Give-A-Way ("Contest").

The Toolbox Sweepstakes will be conducted exclusively online beginning Wednesday, June 1, 2011 and ending Friday July 1, 2011. One winner will be chosen electronically at random from the participants. The prize is a Ranger brand toolbox made up of the [RTB-13DC](#) and [RTB-8DT](#).

### HOW TO ENTER:

Legal residents of the contiguous 48 United States who are eighteen (18) years of age or older will be able to take part in the Toolbox Sweepstakes. To participate in the Toolbox Sweepstakes, participants must do the following:

1. Contestants are to post a thread on their favorite automotive forum linking to [BendPak's "Post For Posts" Contest page](#) [<http://www.bendpak.com/free-car-lift/>].
2. Upon successful posting, Contestants must e-mail [contest@bendpak.com](mailto:contest@bendpak.com) with a link to the forum thread in order to validate the entry.
3. Only the first topic thread about the Post For Posts Contest for any given automotive forum will be considered valid. It is imperative that the Contest announcement not be viewed as "spam."
4. Once the post is verified by a BendPak Team member, the entrant will be entered to win the toolbox.
5. If you post in a private forum, you must send screen shot of your post to [contest@bendpak.com](mailto:contest@bendpak.com) with the date and time of posting clearly visible in the image.
6. Contestants may also enter to win the toolbox on their own Facebook and Twitter profiles.
  - a. Facebook: Post a link to the "Post For Posts" Contest page on your personal Facebook wall, and e-mail the proof to [contest@bendpak.com](mailto:contest@bendpak.com). DO NOT post the link to the BendPak Facebook wall.
  - b. Twitter: Tweet about the BendPak "Post For Posts" Contest on your Twitter feed. Be sure to include a link to the official [BendPak's "Post For Posts" Contest page](#) [<http://www.bendpak.com/free-car-lift/>] as well as the **#postforposts** tag in the Tweet.

7. The Winner will be chosen from all the participants electronically at random.
8. If multiple parties participate in the creation of the entry, only ONE can be deemed the Sweepstakes winner.
9. A single Contestant may enter only be entered once.
10. All entries must be submitted between 12:00 AM PST on June 1, 2011 and 11:59 PM PST on July 1, 2011.

#### **ELIGIBILITY RESTRICTIONS:**

1. The Sweepstakes is open only to legal residents of the United States residing in the lower 48 contiguous U.S. who are 18 years of age or older.
2. Employees of BendPak Inc., its officers, directors, subsidiaries, affiliates, general sponsors, promotional partners, distributors, their respective subsidiaries, affiliates, parent companies, members of the immediate families (defined as spouse, child, sibling, parent, or grandparent), and members of the households (whether related or not) of any of the above are NOT eligible to participate or win in this Sweepstakes.

3. A winner will be chosen electronically at random following the Sweepstakes Period, June 1, 2011 to July 1, 2011.
4. Selection will begin following the Sweepstakes end date.
5. The grand prize winner will be notified via private message, public announcement, e-mail or phone call.
6. Winners will be responsible for accepting delivery, assembly and installation.
7. All decisions made by BendPak Inc. management regarding any aspect of this Sweepstakes are final.
